RE: Steven Becker Purchases

Dear Mayor Robinson:

On March 9, 2010, you requested the Auditor of Public Accounts (APA) conduct an investigation and perform audit procedures specifically concentrating on purchases and charges made with public funds by Steven Becker, a former city employee, during the period of January 1, 2009, through January 13, 2012.

Staff from the APA met with Linda Welsher, City Clerk, on March 13, 2012, to examine purchase invoices and charges made by Mr. Becker for the time period identified above. Mr. Becker worked as the Maintenance Supervisor for the City and was authorized to purchase and charge items related to maintenance of the City. These purchases were all paid by the City of Fort Calhoun.

From the information provided and inquiries with the City of Fort Calhoun staff (staff), the APA noted the following:

- The City owned the following vehicles during the period of January 1, 2009, through January 13, 2012:
 - o 2011 Dodge Charger (Police)
 - o 2010 Ford F250 Pickup
 - o 2010 Caterpillar Skid Steer Loader (Leased)
 - o 2008 Chevrolet Impala (Police) (Traded-in for 2011 Dodge Charger May 2011)
 - o 2008 Ford F250 Pickup
 - o 2001 Elgin Street Sweeper
 - o 1999 Ford F450 Dump Truck
 - o 1996 Ford F250 Pickup (Sold December 2010)
 - 1994 "Traffic" (Radar) Trailer (Gave to Washington County Sheriff's Department November 2011)
 - o 1992 Ford 345C Tractor/Loader
 - o 1988 Ford F250 Pickup
 - o 1980 Chevrolet C60 Sludge Truck

- Per the Nebraska Department of Motor Vehicle records, Steve Becker, or his family, owned the following vehicles during the period of January 1, 2009, through January 13, 2012:
 - o 2004 FourWinds Travel Trailer (RV)
 - o 2003 Ford Escape
 - o 2002 Ford Ranger (Daughter)
 - o 1997 Chevrolet Blazer
 - o 1995 9.00' Daytona
 - o 1995 Pontiac Grand Am
 - o 1994 8.33' Bombardier Corp (Fiberglass) Boat
 - o 1994 Chevrolet Camaro
 - o 1991 9.00' Kawasaki Motors Boat
 - o 1991 Dodge Shadow
 - o 1989 Ford Ranger
 - o 1980 18.00' Chrysler Boat
 - o 1980 Homemade Trailer
 - o 1978 Ford Pickup
 - o 1972 15.75' Quachita (Aluminum) Boat
- Numerous City purchases were made for vehicle repairs, replacement parts, supplies and other products. Several of these purchases appear to be incompatible with the City vehicles. According to City staff, notes were handwritten on some of the invoice/ receipts, per Steven Becker, to indicate the purpose of the purchase. The APA verified with staff that the items purchased were not used or retained by the City. The APA prepared a listing of questioned items, totaling \$4,932.89, which appear to have been for non-City purposes. See Exhibit 1.
- The Mayor has identified \$2,012.45 in questionable purchases by Steve Becker; however, based upon available information, the APA could not determine whether those purchases were actually for City use. See Exhibit 2.
- The City lacked appropriate internal controls:
 - Invoices were not properly reviewed or verified, as is the City's responsibility, before being paid.
 - Files were not kept on vehicle maintenance performed.
 - Various items purchased were not included on an inventory list.
- Due to the pending criminal investigation (District Court Case CR 12 32), information pertaining to the 1999 John Deere Mower was not looked into by the APA. This case is the State of Nebraska versus Steven R. Becker, Count 1 is for Theft by Deception and Count 2 is for Theft by Receiving Stolen Property. Allegedly, on July 18, 2011, the Fort Calhoun City Council approved the purchase of a new mower, with the understanding that the 1999 F-1145 John Deere Mower would be traded-in. The purchase order for the new mower reflected no trade in allowance and, subsequently, the old mower was removed from City insurance and inventory at the request of Mr. Becker. The old mower was found on Mr. Becker's personal property by the Washington County Sheriff's office and charges were subsequently filed.

Neb. Rev. Stat. § 49-14,101.01(2) (Reissue 2010) states, "A public official or public employee shall not use or authorize the use of personnel, resources, property, or funds under his or her official care and control other than in accordance with prescribed constitutional, statutory, and regulatory procedures or use such items, other than compensation provided by law, for personal financial gain." Additionally, Neb. Rev. Stat. § 28-512 (Reissue 2010), which addresses "theft by deception," states, in relevant part: "A person commits theft if he obtains property of another by deception. A person deceives if he intentionally . . . 4) Uses a credit card, charge plate, or any other instrument which purports to evidence an undertaking to pay for property or services delivered or rendered to or upon the order of a designated person or bearer (a) where such instrument has been stolen, forged, revoked, or canceled, or where for any other reason its use by the actor is unauthorized, or (b) where the actor does not have the intention and ability to meet all obligations to the issuer arising out of his use of the instrument."

The items noted by the APA may not account for <u>all</u> purchases with public funds made by Steven Becker, or other City employees, which may have been for personal use; we disclosed only the items discovered in the information provided to us.

We recommend you review the list of questioned items and contact the City or County Attorney to determine any legal action the City may have for recovering funds related to the questionable items. We also recommend the City implement better procedures when reviewing and paying invoices to ensure the City is only paying for expenses that are for the City or City property.
