BUFFALO COUNTY TOWNSHIPS

BACKGROUND

There were 26 townships located in Buffalo County, Nebraska (Townships). Each Township had an elected Board (Boards) that exercised financial accountability and control over activities relevant to the operations of the Township. The Board members of each Township had broad decision-making authority, including the power to levy taxes and to designate management, the ability to exert significant influence over all Township operations, and primary accountability for related fiscal matters. All Buffalo County Townships were dissolved January 2015 by a vote of the people and required to file their inventory and records with the Buffalo County Clerk by January 8, 2015.

Neb. Rev. Stat. § 23-224(8) (Reissue 2012) authorizes a Township to use tax money for the following:

(a) for constructing and repairing roads and bridges within the town to the extent allowed by law; (b) for the prosecution or defense of suits by or against the town or in which it is interested; (c) for any other purpose required by law; (d) for the purpose of building or repairing bridges over streams dividing the town from any other town; (e) for the compensation of town officers at the rate allowed by law and, when no rate is fixed for such amount, as the electors may direct; and (f) for the care and maintenance of abandoned or neglected cemeteries within the town, except that the town board shall not expend more than one hundred dollars in any one year for such purposes.

SUMMARY OF COMMENTS

During our examination of the Buffalo County Townships, we noted certain deficiencies and other operational matters that are presented here.

These comments and recommendations are intended to improve the internal control over financial reporting or result in operational efficiencies in the following areas:

1. ***Questionable Township Payments:*** We identified questionable withdrawal transactions, totaling \$408,258, made by various Townships during the examination period.
2. ***Township Accounts Not Properly Closed:*** We noted the following Townships had bank accounts not properly closed and turned over to the County: Logan, Gardner, Gibbon, and Shelton.
3. ***Turnover of Township Records:*** We noted 19 of the 26 Townships did not turn over all records to the County Clerk upon termination.

More detailed information on the above items is provided hereafter. It should be noted that this report is critical in nature, containing only our comments and recommendations on the areas noted for improvement and does not include our observations on any accounting strengths of the Buffalo County Townships.

A draft copy of this report was furnished to the Buffalo County Attorney to provide an opportunity to review and respond to the comments and recommendations contained herein. All formal responses received have been incorporated into this report. Where no response has been included, the County Attorney declined to respond. Responses that indicate corrective action has been taken were not verified at this time.

COMMENTS AND RECOMMENDATIONS

1. Questionable Township Payments

We identified a significant number of financial transactions for the Townships that were highly questionable. The following table is a summary of those questionable transactions for the examination period tested. The items noted as “Other” are withdrawals made by the Townships that lacked documentation to support the payments were reasonable and proper. More detailed information for each issue is included in the Exhibit.

Beaver Township

- Noted \$1,200 withdrawals to Pleasanton Fire District, Ravenna Fire District, and Sweetwater Cemetery. Also noted \$250 withdrawals to Pleasanton Cemetery, Ravenna Library, and Ravenna Historical Society. All payments were made on January 6, 2015. Buffalo County received \$1,200 from the Ravenna Fire District on February 13, 2015.

Cherry Township

- Noted one check for \$2,100, payable to Sodtown Cemetery on September 4, 2014.

Collins Township

- Noted one check for \$160 with no payee filled in and one check for \$30 payable to Cellar Bar and Grill.

Elm Creek Township

- Noted four checks, totaling \$3,225, payable to Board Members/Employees, which were dated on December 23, 2014, only a few days before the Township terminated.
- Noted two checks payable to law firms, totaling \$1,084

Garfield Township

- Noted one check for \$313, payable to Ravenna Trap Club, on February 12, 2015.

1. Questionable Township Payments (Continued)

Gibbon Township

- Noted one withdrawal for \$20,000 payable to the Gibbon Fire District on January 6, 2015.
- Noted three checks, totaling \$3,000, payable to Board Member/Employees, which were dated on December 31, 2014, only a few days before the Township terminated.
- Noted one withdrawal for \$10,000, payable to the Gibbon Heritage Center, on January 6, 2015.
- Noted 16 withdrawals, totaling \$26,898, paid to vendors/others with no supporting documentation, and two withdrawals, totaling \$173, where no check image was available to support to whom the checks were payable.

Loup Township

- Noted a \$4,000 check, paid to the Pleasanton Volunteer Fire Department, on December 9, 2014.
- Noted \$520 checks, payable to the Pleasant Valley Cemetery and Pleasanton Cemetery, and a \$320 check, payable to St. Mary's Cemetery, on September 16, 2014.

Platte Township

- Noted a \$5,820 check, payable to Gibbon Rural Fire Department, and a \$3,880 check, payable to Shelton Rural Fire Department, on December 17, 2014. Buffalo County received \$5,820 from the Gibbon Rural Fire Department on July 29, 2015.

Riverdale Township

- Noted two checks, totaling \$3,300, payable to an employee for "back pay," which were dated December 18, 2014, and January 7, 2015, the last few days the Township existed.

Schneider Township

- Noted a \$25 check, payable to Ravenna Public Library, on September 8, 2014.

Shelton Township

- Noted two withdrawals, totaling \$65,000, to the Village of Shelton on December 31, 2014.
- Noted four withdrawals, totaling \$35,866, to Shelton Cemetery. The Shelton Cemetery is located in Hall County.

1. Questionable Township Payments (Concluded)

- Noted a bank withdrawal of \$166,885 on September 26, 2014, but no records to indicate where the money was deposited.
- Noted 65 withdrawals, totaling \$2,803, payable to such places as Amazon, Party City, Walmart, and Hobbytown.
- Noted one check, payable to Friends of the Library, for \$8,173, on January 6, 2015, although this check was deposited back into the Township bank account the next day.
- Noted the Township maintained a Cemetery bank account that reflected 95 withdrawals, totaling \$18,458, and a Library bank account that reflected 122 withdrawals, totaling \$23,305. Withdrawals were to vendors and employees and appeared to be appropriate expenses, but there is no documentation to support the Township had authority to use property taxes on cemetery or library functions.

Thornton Township

- Noted one \$150 withdrawal, marked as postage to an employee, on December 19, 2014, only a few days before termination of the Township.

Neb. Rev. Stat. § 23-224(8) (Reissue 2012) authorizes a Township to use tax money for the following:

(a) for constructing and repairing roads and bridges within the town to the extent allowed by law; (b) for the prosecution or defense of suits by or against the town or in which it is interested; (c) for any other purpose required by law; (d) for the purpose of building or repairing bridges over streams dividing the town from any other town; (e) for the compensation of town officers at the rate allowed by law and, when no rate is fixed for such amount, as the electors may direct; and (f) for the care and maintenance of abandoned or neglected cemeteries within the town, except that the town board shall not expend more than one hundred dollars in any one year for such purposes.

There is an increased risk of fraud or abuse when Townships make payments that are not within their statutory authority.

We recommend the Townships provide the Buffalo County Attorney with adequate supporting documentation for the questionable withdrawals noted herein or reimburse the County Treasurer for those unsupported bank withdrawals.

2. Township Accounts Not Properly Closed

As of May 31, 2015, some five months after their dissolution, four Townships had bank accounts that were not properly closed and turned over to the County. Logan Township closed its bank account on August 4, 2015, and remitted the remaining balance to the Buffalo County Treasurer.

Neb. Rev. Stat. § 23-2,100(4) (Supp. 2015), requires, in relevant part, the following:

Upon termination of a township board, the county board shall settle all unfinished business of the township board and shall dispose of all property under ownership of the township. Any proceeds of such sale shall first be disbursed to pay any outstanding obligations of the township, and remaining funds shall be credited to the road fund of the county board.

When accounts are not properly closed after the termination of the Township, there is an increased risk of loss or misuse of funds, and such Townships are in non-compliance with State statute.

We recommend the Townships close all remaining bank accounts and properly remit the money to the County Treasurer.

3. Turnover of Township Records

We identified a significant number of accounting records that were not turned over to the County Clerk upon termination of the Townships in January 2015. The following is a summary of those records:

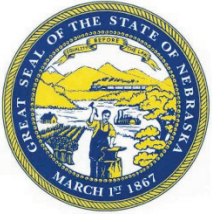

3. Turnover of Township Records (Concluded)

Any remaining township board members serving as of the date of termination shall deposit with the county clerk all township records, papers, and documents pertaining to the affairs of the township and shall certify to the county clerk the amount of outstanding indebtedness in existence on the date of termination.

When records are not properly turned over after the termination of the Townships, there is an increased risk of loss of misuse of funds, and such Townships are in non-compliance with State statute.

We recommend the Townships turn over any remaining records to the County Clerk.

INDEPENDENT ACCOUNTANT'S REPORT

Buffalo County Townships
Buffalo County Nebraska

We have examined the accompanying Schedule of Bank Activity of the Buffalo County Townships (Townships) for the period of January 1, 2014, through May 31, 2015. The Townships' management is responsible for the Schedule of Bank Activity. Our responsibility is to express an opinion based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and the standards applicable to attestation engagements contained in *Government Auditing Standards*, issued by the Comptroller General of the United States and, accordingly, included examining, on a test basis, evidence supporting the Schedule of Bank Activity and performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion.

In our opinion, the schedule referred to above presents, in all material respects, Bank Activity of the Townships for the period of January 1, 2014, through May 31, 2015, based on the accounting system and procedures, as described in Note 1.

In accordance with *Government Auditing Standards*, we are required to report findings of deficiencies in internal control, violations of provisions of contracts or grant agreements, and abuse that are material to the Schedule of Bank Activity and any fraud and illegal acts that are more than inconsequential that come to our attention during our examination. We are also required to obtain the views of management on those matters. We performed our examination to express an opinion on whether the Schedule of Bank Activity is presented in accordance with the criteria described above and not for the purpose of expressing an opinion on the internal control over the Schedule of Bank Activity or on compliance and other matters; accordingly, we express no such opinions. Our examination disclosed certain findings that are required to be reported under *Government Auditing Standards*, and those findings, along with the views of management, are described in the Comments Section of the report.

This report is intended solely for the information and use of the Buffalo County Attorney, management, others within the Townships, and the appropriate Federal and regulatory agencies, and it is not intended to be, and should not be, used by anyone other than these specified parties. However, this report is a matter of public record, and its distribution is not limited.

1. Criteria

The financial information used to prepare the Schedule of Bank Activity (Schedule) for the Buffalo County Townships was obtained from the individual Townships' bank statements received from the Buffalo County Attorney. Interest and deposits are shown as receipts while deductions are shown as disbursements.

2. Reporting Entity

The Buffalo County Townships were governmental entities governed by the laws of the State of Nebraska. Each individual Township was managed by a Board that exercised control over activities that were relevant to the operations of the Township. The Schedule does not include those transactions that did not post to the bank that may have been dated within the period of the examination. The APA obtained the bank account activity from the Township records and various banks.

3. Transfers

Items noted as transfers on the Schedule were deposits and withdrawals between various bank accounts held by the Townships. Activity is detailed out in the exhibit.
