Dear Mr. Wiltgen:

As you know, the Auditor of Public Accounts (APA) recently examined the expense reimbursement documents of Andy Stebbing, the Lancaster County Treasurer (Treasurer), for the three previous fiscal years. This examination was done at the request of the Nebraska Attorney General's office.

Based upon both the outcome of this preliminary audit planning work and our examination of the expense reimbursements, we have determined that the APA does not need to complete a separate financial audit or attestation of the County at this time. The information contained herein is the APA's summary of the information obtained and the related issues noted.

The APA obtained a listing of reimbursement payments made to the Treasurer by the County. The County also provided copies of all those claims and their supporting documentation. A summary of the Treasurer's expense reimbursements is provided in the table below:

The information examined by the APA is compiled in **Exhibits A & B**, which are attached hereto. See **Exhibit A** for details of the Treasurer's expense reimbursements paid by the County as prepared by the APA. The majority of the expense reimbursements paid to the Treasurer were for mileage, totaling \$3,385.62. See **Exhibit B** for the details found on the mileage logs provided, as prepared by the APA.

The APA worked with the County and the Treasurer to gather as much supporting documentation as was available for the reimbursement payments at issue. While some explanations were provided as possible purposes of the trips for which reimbursements had been made, the specific dates and details were not documented and, therefore, were unavailable for examination.

The Lancaster County Board (Board) lacked proper controls to ensure that expenses claimed by the Treasurer were accurate or supported by adequate documentation. For instance, the Treasurer completed and approved his own mileage log reimbursement claims, which were then submitted to the County Clerk for processing the payment. As we understand it, the practice of the County Clerk's office was to ensure only that claims submitted by elected official were footed and calculated correctly no further details were sought or verified. According to the Treasurer, since his election in 2011, neither the County Clerk nor anyone else has requested additional documentation for his mileage reimbursement claims.

During the course of the preliminary planning work and examination of specific expense reimbursements, the APA has identified the following potential issues related to the Treasurer's expense reimbursements:

Purpose of Travel Not Identified: The Treasurer's mileage logs obtained by the APA date back to mileage incurred in June 2014 through February 2017. These logs contain a total of 568 (one with no date) days of mileage claimed for reimbursement. However, only four of those days included the purpose of the trip.

Unreasonable Mileage: In most cases, the mileage reimbursed appeared to be questionable, unreasonable, or not supported based on the locations of travel stated on the expense forms, as follows:

• Forty-four days and 448 miles contained no documentation to support the miles claimed. Additionally, the location or destination of travel was not provided or documented. In one instance, moreover, the date of travel was not listed.

• Eleven days and 112 miles were claimed for travel to "Carpetland," apparently referencing Carpet Land, which has a store at 4301 Industrial Avenue in Lincoln, Nebraska. No documentation was provided to support any of the almost one dozen trips to that same location, which inexplicably varied in distance from 6 to 14 miles each.

• The APA asked the County to provide the Treasurer's gate access records for the County-City Building parking garage. The County had information dating back only to January 1, 2017. Nevertheless, per comparison of the Treasurer's mileage logs to the available gate information, only 18 of the 41 travel days claimed involved gate access to the County-City Building parking garage.

Varying Mileage Claimed: Varying mileage claimed to and from the same locations was not questioned, as shown below:

- Forty-five days and 465 miles were claimed for travel to a location at 46th and R Streets in Lincoln, NE. The distance claimed per day varied from 3 to 16 miles.
- Thirty-nine days and 366 miles were claimed for travel to a location at 500 West O Street in Lincoln, NE. The distance claimed per day varied from 3 to 20 miles.
- Twelve days and 126 miles were claimed for travel to the "Capitol." The distance claimed per day varied from 6 to 12 miles.

Per the MapQuest.com website, the actual mileage to the various locations claimed would be as follows:

- DT (Downtown-555 S 10^{th} Street) to 46R (625 N 46^{th} Street) = 3.4 miles one way.
- WO (500 West O Street) 46R (625 N 46th Street) = 4.9 miles one way.
- DT (Downtown-555 S 10th Street) to WO (500 West O Street) = 1.3 miles one way.
- DT (Downtown-555 S 10th Street) to the State Capitol (1445 K Street) = .4 miles one way.

Based solely upon the information provided on the expense reimbursement forms, it is difficult, if not impossible, to determine whether more than one trip was made to the identified location on the same day or the actual number of miles that should have been claimed for the aforementioned travel.

The payment of certain travel expenses is authorized by the Local Government Miscellaneous Expenditure Act (Act), which is set out at Neb. Rev. Stat. §§13-2201 through 13-2204 (Reissue 2012). Specifically, § 13-2203(1)(a) of the Act allows for following:

The expenditure of public funds for the payment or reimbursement of actual and necessary expenses incurred by elected and appointed officials, employees, or volunteers at educational workshops, conferences, training programs, official functions, hearings, or meetings, whether incurred within or outside the boundaries of the local government, if the governing body gave prior approval for participation or attendance at the event and for payment or reimbursement either by the formal adoption of a uniform policy or by a formal vote of the governing body. Authorized expenses may include:

* * * *

(ii) Mileage at the rate allowed by section 81-1176 or actual travel expense if travel is authorized by commercial or charter means[.]

Furthermore, County Resolution R-14-0032, dated June 24, 2014, constitutes the Board's policy for the payment or reimbursement of actual and necessary expenses incurred by elected officials of Lancaster County, appointed officials, employees, and volunteers. Section I of the Policy states, in part, the following:

Anyone authorized to travel for the benefit of the County has a responsibility to keep accurate, substantiated costs records, and to submit expense statements in accordance with this resolution.

The County's reimbursement process is also specified in that same policy. Section I (E)(1) requires an itemized travel expense statement, along with necessary receipts and other documentation.

The Board's policy also directs the County Clerk to scrutinize reimbursement requests prior to payment. Section I (E)(3) states the following:

Upon receipt of the request for funds, the County Clerk shall examine the request to insure compliance with this resolution. The County Clerk is authorized to request and receive additional information on any and all expense prior to action by the County Board.

Additionally, Neb. Rev. Stat. § 23-109 (Reissue 2012) provides the following:

- (1) The county board shall have power to examine and settle all accounts against the county and all accounts concerning the receipts and expenditures of the county.
- (2) The county board may adopt by resolution an imprest system of accounting for the county and authorize the county clerk to establish an imprest vendor, payroll, or other account for the payment of county warrants in accordance with any guidelines issued by the Auditor of Public Accounts.

Given the lack of documentation provided to substantiate and support the Treasurer's mileage reimbursements requests, the subsequent payments by the County do not appear to have been made in accordance with either State statute or the Board's own policy for the reimbursement of actual and necessary expenses.

The implications of the information provided herein are twofold. To start, any verifiable proof of the intentional falsification of expense reimbursement request forms could be grounds for considering, among other things, the applicability of both Neb. Rev. Stat. § 23-135.01 (Cum. Supp. 2016) and Neb. Rev. Stat. § 23-1603 (Reissue 2012) to such circumstances.

Neb. Rev. Stat. § 23-135.01 (Cum. Supp. 2016) says the following:

Whoever files any claim against any county as provided in section 23-135, knowing the claim to contain any false statement or representation as to a material fact, or whoever obtains or receives any money or any warrant for money from any county knowing that the claim therefor was based on a false statement or representation as to a material fact, if the amount claimed or money obtained or received or if the face value of the warrant for money shall be one thousand five hundred dollars or more, shall be guilty of a Class IV felony. If the amount is five hundred dollars or more but less than one thousand five hundred dollars, the person so offending shall be guilty of a Class II misdemeanor. If the amount is less than five hundred dollars, the person so offending shall be guilty of a Class III misdemeanor.

Neb. Rev. Stat. § 23-1603 (Reissue 2012) provides the following:

If any county treasurer shall neglect or refuse to render any account or settlement required by law, or shall fail or neglect to account for any balance due the state, county, township, school district, or any other municipal subdivision, or is guilty of any other misconduct in office, the county board may forthwith remove him from office, and appoint some suitable person to perform the duties of treasurer until his successor is elected or appointed and qualified.

Secondly, as discussed previously with County personnel, the Board lacked procedures for ensuring that expense reimbursement requests were properly substantiated prior to approval and payment. It is doubtful that the payments in question would have been made had the Treasurer's reimbursement requests been subjected to even the most cursory examination, not to mention the heightened level of scrutiny not only permitted under § 23-109 put also suggested by Section I (E)(3) of the Board's own policy. We understand that the Board has taken recent steps to improve its expense reimbursement procedures; however, we have not examined any reimbursement claims since such changes were implemented.

We do recommend the Board exercise its authority under both State statute and its own policy to examine and settle all claims against the County, including those for expense reimbursements. Additionally, the Board should continue to strengthen its reimbursement procedures by implementing a formal review of all expenses requested by elected officials. Finally, the Board should confer with the County Attorney regarding any possible legal ramifications of the information provide herein.
