Dear Ms. Horn:

As you may know, the Nebraska Auditor of Public Accounts (APA) received a number of concerns related to the financial situation of the Fullerton Area Senior Center (Center). In response to those concerns, the APA began limited preliminary planning work to determine if a full financial audit or attestation would be warranted. Pursuant thereto, the APA obtained certain information regarding the Center's finances.

Based upon a review of the information obtained, the APA has determined that a financial audit or attestation by our office is not required at this time. Nevertheless, during the course of the preliminary planning work, the APA noted certain issues that merit corrective action, as presented below.

Background

The Center is a non-profit corporation established in 1990. The Center received funding from the Northeast Nebraska Area Agency on Aging (NENAAA) in the form of reimbursements for nutritional services and other assistance provided under the Older Americans Act of 1965. The Center also collected contributions from clients for meals, but it generated minimal revenues through its own fundraising efforts.

Operation of the transportation services, called "Nance Trans," began as a function of the Center's Board of Directors (Board) prior to May 2019. This is evidenced in the Board's meeting minutes for that month, which references a "Nance Trans Report." Pay rates and hiring decisions for Nance Trans employees were also discussed in the Board's meeting minutes. The Center even created a "Nance Trans Driver's Handbook," which served as the Personnel Policy for that transportation services provider. Additionally, the Center's employer identification number was used for the Nance Trans bank account.

Despite having operated under the control and guidance of the Board, NanceTrans, Inc. filed with the Nebraska Secretary of State as an independent nonprofit corporation on May 2, 2019. Funding for Nance Trans was provided by the State's Department of Transportation and fares.

Prior to that time, in August and October 2018, the NENAAA performed a subrecipient monitoring "audit" and follow-up procedures for the Center. A number of financial concerns were raised during that review, including the need to separate the transportation service funds from the senior services funds, the lack of documentation to support credit card purchases, and the late filing of payroll taxes. In November 2018, requested statements for the Sam's Club credit cards utilized by the Center had still not been provided to the NENAAA.

In January and March 2019, the NENAAA conducted other unannounced evaluations of the Center. Many of the same issues were identified. In April 2019, the NENAAA began to withhold funds from the Center. The funds were released in May 2019, but the Center ultimately closed its doors on June 1, 2019.

The Fullerton City Administrator contacted the APA on June 21, 2019, explaining that he had received the records from the Center and thought that we should review them. The APA obtained those records on June 25, 2019.

Findings and Recommendations

1. Unauthorized Leave Payments

The Center appears to have paid holiday and leave hours to employees who were not entitled to such benefits under either the Nance Trans Driver's Handbook or the Fullerton Area Senior Center, Inc., Personnel Policy.

The APA reviewed all checks paid to four employees during 2019: Sandy VanDeWalle, the Director of the Center; Billy VanDeWalle, Nance Trans Manager; Damien VanDeWalle, a cook for the Center; and Jessie Spencer, a driver for Nance Trans. The APA was told that all four employees are related.

The APA determined that Sandy VanDeWalle and Billy VanDeWalle received leave and holiday pay for which they were ineligible, as follows:

The Center defines a full-time employee in its Personnel Policy as "an employee working at least forty (40) hours in a work week on a regular basis and whose duration of employment is not limited[.]" The Policy states specifically that part-time employees are not entitled to vacation or sick leave. Holiday leave is also provided only for full time employees.

Likewise, the Nance Trans Driver's Handbook has similar language restricting leave for only full-time employees.

During 2019, Mr. and Mrs. VanDeWalle were paid for the following number of total hours worked, which included the aforementioned leave hours:

At no time during 2019 did either employee meet the definition of a full-time employee; therefore, neither were entitled to leave pay.

Additionally, as shown above, Mr. and Mrs. VanDeWalle were each paid 32 holiday hours for the pay period December 23, 2018, through January 5, 2019, which was 16 more holiday hours than allowed per policy.

The Personnel Manual for each entity included the same holiday schedule. Below is the holiday schedule taken from the Center's Personnel Manual:

The holidays observed are: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Day after Thanksgiving, Christmas, and Good Friday.

According to the Center's Board, Sandy VanDeWalle was responsible for the preparation of employee paychecks.

Without adequate controls to ensure that payments to employees comply with provisions of an employee personnel manual, there is an increased risk of loss or misuse of funds.

We recommend the Board review the information provided herein and determine whether there was any formal approval for the leave payments by the Board. Because this comment addresses the possible misappropriation of funds, the APA will refer the matter to the Nance County Attorney.

2. <u>Lack of Documentation for Pay Rates</u>

According to the Board, all rates of pay for Center employees should be documented its meeting minutes. However, the rate of pay for the employees tested did not agree to documentation provided by the Board or lacked documentation altogether.

Sandy VanDeWalle was paid \$13.25 per hour when working for Nance Trans. The APA found no documentation for this rate in the Board's meeting minutes dating back to February 2017. The following table shows the payments to Mrs. VanDeWalle during 2019 using that rate:

The APA also identified three paychecks with rates different from the \$13.25 noted above, all of which also lack adequate authorization. These were the final paychecks received by Mrs. VanDeWalle, as follows:

Similarly, the APA determined that the hourly rate of pay for Billy VanDeWalle lacked authorization from the Board. In its September 2017 meeting minutes, the Board hired Mr. VanDeWalle as the manager for Nance Trans. The rate of pay was not specified in the meeting minutes. The meeting minutes from August 2018 show the Board approval of \$12 per hour for Bill VanDeWalle. However, he was paid \$13.25 per hour throughout 2019, as shown in the table below:

Jessie Spencer was a driver for Nance Trans and received an hourly rate of pay of \$12.25. The APA was told that he is related to Mr. and Mrs. VanDeWalle. The Board lacked documentation to support the rate of pay for Mr. Spencer. The following are the payments made to him in 2019:

Damien VanDeWalle was a part-time cook for the Center. Upon his hire in August 2017, the Board authorized a rate of pay of \$9.25 per hour. Two of his four paychecks in 2019 included a rate of pay at \$10 per hour, as follows:

Without procedures to ensure that only the authorized amounts are paid to employees, there is a risk for the loss or misuse of funds.

We recommend the Board determine if the rates of pay identified above were authorized. Because this comment addresses the possible misappropriation of funds, the APA will refer the matter to the Nance County Attorney.

3. <u>Timesheet Issues</u>

The APA noted the following issues related to the timesheets completed by Center employees:

Timesheets Were Not Signed

The APA noted that many of the timesheets for each of the four employees tested lacked any supervisory approval of the time worked, as summarized below:

As shown above, Mrs. VanDeWalle was paid for 10 hours of sick leave and 30 hours of work time, which does not agree to the 27.5 work hours recorded on the timesheet.

Without procedures to ensure that amounts paid agree to the approved time records, there is an increased risk for loss or misuse of funds.

We recommend the Board determine whether the employee pay amounts identified in this finding were authorized and whether the Board should seek to recover any unauthorized payments.

4. <u>Credit Cards</u>

The Board allowed the Director to make credit card purchases using a Sam's Club credit card. The APA obtained the credit card statement from July 2017 through June 6, 2019. The credit card activity is included in **Attachment A**. The few items highlighted in yellow would be questionable purchases.

While most of the activity appears to have been for food related items for use in the senior center, the APA noted that the Board paid an unusually large amount of interest and fees in the two year period reviewed, as noted below:

Good internal controls and sound business practices requires procedures to ensure the timely payment of credit card purchases to minimize the amount of interest and late payments. Without such procedures, there is an increased risk for loss of public funds.

The Fullerton Area Senior Center Board is no longer active. However, we recommend the new Nance Trans Board of Directors implement procedures to ensure the timely payment of credit card bills to prevent significant interest and late fees.

Overall Center Response: By a unanimous vote of 6-0, with one Board Member absent, the Fullerton Area Senior Center agrees with the findings of the Nebraska Auditor of Public Accounts regarding misappropriation of funds by Sandy and William VanDeWalle Jr.

One additional item we came to our attention. On page 7 of the document regarding Sandy VanDeWalle's Time Sheet for January 6-19, 2019, we see that the Supervisor Signature is that of Tom Barbour. This is not the true and legal signature of Tom Barbour, Secretary of the Board.
