Such inventory shall set forth a description of such properties with sufficient details that the property may be identified in the records of the register of deeds and shall set forth, if within an area in which the property abuts upon a street, the street and street number of such property and shall set forth the use being made of such property. The county clerk shall retain inventory for filing as a public record in his or her office in a manner convenient for reference.
