INTERLOCAL COOPERATION AGREEMENT

This two year Agreement made and entered into between the Gardner Township, hereinafter referred to as "TOWNSHIP" and the County of Buffalo, hereinafter referred to as "COUNTY" and has been approved by the governing bodies of the Township and County.

The Township and the County hereby enter into this Agreement under and by virtue of the power to do so granted by the Interlocal Cooperation Act, Section 13-801 through 13-827, inclusive R.R.S. (1991).

IT IS AGREED that the County will furnish all machinery with operator necessary for the roadtop maintenance, mowing and snow removal for the following roadways within the Township:

IT IS FURTHER AGREED that the County will perform all maintenance activities in a safe and efficient manner in accordance with the rules and regulations of the law as well as the policy of the Buffalo County Highway Department

THE ABOVE-NAMED TOWNSHIP will pay the County the amount of \$40.00 per hour for maintenance and snow removal and \$15.00 per hour for mowing of weeds.

Maintenance, snow removal and mowing are to be under the direction of the County Highway Superintendent.

IT IS FURTHER AGREED that the County will do the maintenance and mowing of all roads under the jurisdiction of the Township and will remove snow on all Township roads except those specified:
